AN ORDINANCE AMENDING CHAPTER 1024.04 OF THE BALTIMORE CODIFIED ORDINANCES (WATER SERVICE CHARGES) AND THE DECLARATION OF AN EMERGENCY

WHEREAS, the Village desires to amend the Water Service Charges as set forth in Chapter 1024.04 of the Codified Ordinances in order to establish new fees for Village water service customers whose properties are located outside the Village corporation limits; and,

WHEREAS, Finance Committee has reviewed the proposed amendments and recommends adoption of the same;

WHEREAS, this legislation needs to be adopted on an emergency basis in order for the amendments to be effective as of January 1, 2014;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL
OF THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY,
OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:

SECTION 1: That Chapter 1024.04 of the Baltimore Codified Ordinances (Water Service Charges), which currently reads in relevant part as follows:

“1024.04 WATER SERVICE CHARGES.

(b) Outside the Village Corporation Limits.

Effective January 1, 2014 and thereafter, the water service rates for Village of Baltimore water service customers whose properties being serviced are located outside the Village corporation limits, shall be at the following percentages of the rates then in effect for water service customers whose properties being serviced are located inside the Village corporate limits:

January 1, 2014	300% (three hundred percent)
January 1, 2015	350% (three hundred fifty percent)
January 1, 2016	400% (four hundred percent)
January 1, 2017	450% (four hundred fifty percent)
January 1, 2018	500% (five hundred percent)
January 1, 2019	550% (five hundred fifty percent)
January 1, 2020	600% (six hundred percent)
January 1, 2021	650% (six hundred fifty percent)
January 1, 2022	700% (seven hundred percent)
January 1, 2023	750% (seven hundred fifty percent)”

is hereby amended and shall henceforth read as follows:

“1024.04 WATER SERVICE CHARGES.

(b) Outside the Village Corporation Limits.

Effective January 1, 2014 and thereafter, the water service rates for Village of Baltimore water service customers whose properties being serviced are located outside the Village corporation limits, shall be at the following percentage of the rates then in effect for water service customers whose properties being serviced are located inside the Village corporate limits:

January 1, 2014	200% (two hundred percent)”
