**AN ORDINANCE TO ENTER INTO AN AGREEMENT WITH
THE OHIO DEPARTMENT OF TRANSPORTATION TO
PARTICIPATE IN THE PURCHASE OF SODIUM CHLORIDE
(ROCK SALT) FOR THE 2015-2016 WINTER SEASON
AND THE DECLARATION OF AN EMERGENCY**

WHEREAS, Section 5513.01(B) of the Ohio Revised Code provides the opportunity for Counties, Townships, Municipal Corporations, Port Authorities, Regional Transit Authorities, State Colleges/Universities and County Transit Boards to participate in contracts of the Ohio Department of Transportation for the purchase of machinery, material, supplies, or other articles; and


WHEREAS, the Village desires to participate in the purchase of sodium chloride (rock salt) for the 2015-2016 winter season with the Ohio Department of Transportation (ODOT); and

WHEREAS, since the agreement for the purchase of rock salt with ODOT needs to be submitted prior to April _____, 2015, this ordinance will need to be passed on an emergency basis;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF
THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY, OHIO,
THREE-FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

SECTION 1: That the Village Administrator is hereby authorized to enter into an agreement with the Ohio Department of Transportation for Sodium Chloride (rock salt). A copy of the Agreement is attached hereto and incorporated herein as Exhibit A, setting forth all of the terms and conditions.




