AN ORDINANCE AMENDING ORDINANCE 2015-27 (AN ORDINANCE VACATING THE UNOPENED ALLEY BETWEEN 1412 CANAL STREET AND 117 & 0 SOUTH HIGH STREET) AND THE DECLARATION OF AN EMERGENCY

WHEREAS, the Village approved Ordinance 2015-27 (An Ordinance Vacating the Unopened Alley Between 1412 Canal Street and 117 & 0 South High Street) on August 24, 2015; and,


WHEREAS, the Fairfield County Engineer has requested modifications, for clarity purposes, to the legal description of the portion of unopened alley to be vacated; and,

WHEREAS, as the original ordinance will be effective as of September 24, 2015, this legislation needs to be passed as an emergency;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY, OHIO, THREE-FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

SECTION 1: The unopened alley located between Lots 39E and 40E of Original Town (1412 Canal Street, being Tax Parcel No. 0240212300), and Lots 25 and 26 of Original Town (0 South High Street, being Tax Parcel No. 0240210700; and 117 South High Street, being Tax Parcel No. 0240210800, respectively), is hereby vacated. An updated copy of the drawing showing the unimproved ailey is attached hereto and incorporated herein.

SECTION 2: For the reasons noted in the preamble, this ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, morals, and welfare of the citizens of Baltimore, Ohio. This ordinance shall become effective upon its passage by Council.
