Ordinance No. 2015- 42

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO EXECUTE AN AGREEMENT BETWEEN THE VILLAGE OF BALTIMORE AND INTRINSIC SERVICES, LLC, FOR THE REMOVAL OF BIOSOLID MATERIALS FROM THE WASTEWATER TREATMENT PLANT AND THE DECLARATION OF AN EMERGENCY**

WHEREAS, it is the desire of the Village of Baltimore to renew its contract with Intrinsic Services, LLC, (the contractor), for the removal of non-hazardous liquid biosolids from the Village's Wastewater Treatment Plant; and,

WHEREAS, the proposed professional services agreement submitted by Intrinsic Services, LLC, sets forth the terms of the agreement between the Village and the contractor, including the services to be provided by the contractor and the fees to be paid by the Village for such services; and,


WHEREAS, Service Committee has reviewed the proposed agreement and recommends approval of the same; and,

WHEREAS, this ordinance needs to be approved on an emergency basis due to the recent expiration of the previous agreement and the need to provide a continuity of service to the Village;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY, OHIO, THREE-FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

SECTION 1: That the Village Administrator is hereby authorized to execute a new professional services agreement with Intrinsic Services, LLC, for the removal of non-hazardous liquid biosolids from the Village's Wastewater Treatment Plant, for a five (5) year time period commencing October 15, 2015, upon the terms and conditions set forth in the agreement, a copy of which is attached hereto and incorporated herein.

SECTION 2: For the reasons noted in the preamble, this Ordinance is declared to be an emergency measure necessary for the health, safety and general welfare of the community. Therefore, this ordinance shall become effective immediately upon its passage by Council.
